University Faculty Council Meeting

Minutes of the Meeting April 25, 2023 | Tower Ballroom, IUPUI

Meeting start time: 1:30 pm

1. Approval of the minutes of December 13, 2022

Meetings of minute motion made, seconded and approved.

2. Executive Committee Business

Cate Reck, Joseph Wert, and Philip Goff, Co-chairs of the University Faculty Council Collin Johnson will be incoming co-chair for IU Bloomington.

Phil Goff will continue as co-chair of IUPUI.

Joe Wert stepping down after 7 years as co-chair.

General thanks to all committee members.

Cate Reck updates: Bloomington Faculty Council (BFC) representatives, 20 search committees, reinstatement of the student appointment of the academic affairs committee for SAA hires and SAA remediation committee, successful task force and town hall meetings, task force of SAA grievance and board of review, updated review procedures for administrator on the Bloomington campus, unfolding of the strategic plan, flexible updates to the IUB university admissions policy, rolling back of end of semester deadlines to precovid policies, changes to the bylaws and constitution.

Philip Goff updates: realignment of IUPUI and vision 2024; Strategic planning; IFC has tried to protect faculty moving to Purdue administration and will monitor effects on affected faculty; looking forward to the future, including challenges associated with the realignment and implementing the strategic plan.

3. Presiding Officer's Report

President Whitten updates:

IU 2030 strategic planning

Board of Trusties endorsed the IU 2030 comprehensive university-wide strategic plan and 8 individual plans for the individual campuses and school of medicine: champion student success across the state; advance goal of transformative research and creative activity; serve state more effectively and beyond to improve Hoosier health.

All campuses have identified goals and measurable metrics

Established executive implementation council to lead central implementation

Established Implementation committees as well as campus level implementation teams

Office of institutional analytics will help track campus metrics.

Vision 2024 planning

- Transformation of the Indianapolis Campus and realignment of IU and Purdue: August 2022 Board of Trustees at
 each university came together to approve MOU which outlined intentions to transform IUPUI into separate
 entities and both govern their own universities.
- Plan will allow both institutions to play to our respective strengths in the life sciences and engineering to increase the number of job ready graduates, to fuel economic growth, to enhance service to the Indianapolis community and beyond. On the IU side, we will have the opportunity to build upon Humanities, Business and health sciences and Art and Law and others on our campus.
- Campus committee members have created roadmap for transition to IU Indianapolis
- Ten IU task forces with 125 campus community members
- Working group of Indianapolis business, non-profits and civic and internal leaders complement the work of task forces.
- Planning underway for science and technology corridor on the Indianapolis campus that will create new
 opportunities for IU students in stem fields; informatics, computing, advanced certificates, and research
 programs that need targeted regional workforce needs, making us cornerstone partner to state and the business
 community.

- At the end of March, the ten taskforces submitted templates that encapsulated the issues associated with each of their respective areas of alignment.
- General councils of IU and Purdue are discussing points to include in the definitive agreements anticipated to be signed at the end of the semester or early summer.
- Once the definitive agreement is signed, we will remain IUPUI until next year, then we will implement all the steps to implement; IU-Indianapolis becomes official in the Fall, 2024.

Bi-annual budget update

Budget is in process; will need state resources to achieve success for Strategic plan and Vision 2024; requested appropriations for the next 2 years; determined funding priorities for legislative support, engaged legislators and policy makers who are understanding and supportive of the vision; worked with government relations office.

Refresher of budget:

- requested no new line items; and asked for inflationary increase of 2.5 % for existing line items.
- capital project request was focused on deferred maintenance for regional campuses and renovations to laboratories in Bloomington, renovations of IU School of Nursing infrastructure, renovations to portions of the Wells quad and school of Public Health in Bloomington, and operations support for IU, Indianapolis.
- General assembly will conclude its business in a few days and we'll find out.
- Next month, Indiana Commission of Higher Ed will issue its tuition and fee guidance, and then in June the IU trustees will approve tuition and fee rates for the upcoming biannual as well.
- IU commencement season starting soon.

Question/Comment Period

Q: Faculty role in executing the strategic plan going into next year?

A: Each of campus leads are the final stages of defining the processes they will use.

- Bloomington: developing implementation committee, which will be a mix faculty, staff, student and admin; draft time, significant involvement of faculty
- Regional campuses: each campus will design its own process for how they want to move forward. The chancellors have started the conversation.
- Indianapolis: structure is being put into place and will be conferring with IFC; time line will be to bring together vice chancellors in June to structure the implementation plan; deans council retreat in August and the theme will be the implementation of the strategic plan.

Q. Update on transition for Purdue faculty?

A. Tenure track professors all had to apply to be membership in departments. Many of them were being turned down for membership in that department, and there is no appeal process. About 2 dozen of our tenure-track faculty have decided not to do this and will be leaving or retiring; others are still waiting. Non-tenure track faculty still have not heard back yet and will not hear anything until the final agreement is struck.

Q: IU east: we had wanted sustainability related processes and procedures as part of system of the strategic plan.

A. Climate action plan group has been working close to a year and have met multiple time and are supposed to provide a recommendation report later this year.
