Indiana University University Faculty Council Summary of Actions Taken 2022-2023

Amendments to ACA-33 Academic Appointee Responsibilities and Conduct

Professor Emeritus and Chair of the UFC Policy Review Committee Alexander Tanford presented amendments to ACA-33, Code of Academic Ethics. The amendments added a clarification on whether an instructor must report all instances of student dishonesty to the campus student affairs office, a new section on work-life balance, and a clarification on whether the initial investigation of a misconduct complaint should be undertaken by the administration or a faculty committee, at least in serious cases. The amendments passed unanimously by Zoom vote.

Creation of UA-15 Review of University Administrative Offices

Vice President and Chief Human Resources Officer Todd Richardson and Professor Emeritus and Chair of the UFC Policy Review Committee Alexander Tanford presented a new UA policy detailing how comprehensive reviews of the highest offices at Indiana University will be conducted. The motion was voted on by a show of hands and passed.

Amendments to STU-00 Code of Student Rights, Responsibilities, & Conduct

Vice President for Student Success Julie Payne-Kirchmeier and Professor Emeritus and Chair of the UFC Policy Review Committee Alexander Tanford proposed a range of amendments to STU-00. Discussion followed, and a motion was made to amend the word "intent." The amendment passed. The Council voted by a show of hands to pass the initial motion, as amended.

Amendments to STU-00 Code of Student Rights, Responsibilities, & Conduct

Professor Emeritus and Chair of the UFC Policy Review Committee Alexander Tanford proposed amendments to STU-00, which added two introductory statements, redrafted the bullying section to drop the word "intent," added a prohibition against the use and possession of drugs, and added a qualification that ACP students who are still in high school are subject only to the academic misconduct section and not the personal misconduct section. The changes were sent to the entire council and then voted on two weeks later and passed unanimously by the UFC Executive Committee by electronic vote.
